Due to the extensive work & cost required to meet the new safety standards and pass inspection, membership dues for the 2009 season will increase to \$515 for stockholders, \$370 for stock-holding empty nesters, and to \$655 for annual members, and are due by April 5<sup>th</sup>. Payments for current members received after the 5<sup>th</sup> will incur a \$15 late fee, and after May 5<sup>th</sup>, a \$30 late fee. If you are a current member and do not wish to re-join, you must notify the treasurer in writing prior to May 1<sup>st</sup> and return your tennis key to avoid an assessment. To convert to a stockholding membership, the \$500 stock payment may be paid over 3 years (\$200, \$200, \$100). *If you are considering the Empty Nester membership and you have children, grandchildren, or houseguests who will use the pool on a regular basis, we ask that you please join at the regular family rate of \$515, and list them as members of your household on the Emergency Contact Form.
