

WOOD VALLEY SWIM & RACQUET CLUB, INC. RULES AND REGULATIONS

SECTION I: GENERAL RULES These rules and regulations are for the benefit and protection of all members and guests of the Wood Valley Swim & Racquet Club. They have been established to assure the safe and sanitary operation and use of the pool facilities and adjacent areas, and also to provide enjoyable recreation to all members and their guests. Failure to comply with any of these rules may be considered sufficient cause for suspension of club privileges. The Pool Lifeguards have been delegated responsibility by the Board for safety, order, and cleanliness in and around the pool and adjacent grounds including daily enforcement of these rules and regulations. Lifeguard Managers shall have the authority to suspend pool privileges for a period not to exceed three (3) days. The Lifeguard Managers may also recommend to the Board of Directors suspensions longer than three (3) days for good and sufficient cause. All members are expected to show the pool Managers and/or Lifeguards proper respect and cooperation at all times. Parents are requested to review these rules with their children and to encourage their cooperation and support. Complaints about any Life Guards/Managers including questions about any decisions should be made in writing to the Board of Directors. Members are responsible for all damage done by themselves, their families, and/or their guests. Any person caught stealing or vandalizing Club property will be turned over to the proper legal authorities and may have their Club privileges suspended. All laws in effect within the State of North Carolina are applicable on Club property as well. The Wood Valley Swim & Racquet Club is not responsible for loss of and/or damage to personal belongings or vehicles on Club property. Intoxicated or disruptive persons will not be permitted on Club property. No pets will be allowed on Club property. The breezeway and gate area of the bath house must be kept clear at all times. There shall be no loitering or congregating of members in this area. Excessive noises emanating from loudspeakers, portable radios, etc. is prohibited. The use of the word "adult" in these rules and regulations shall be interpreted to be any responsible person, age eighteen (18) or older, who is part of the member's household. "Guardian" shall be interpreted to mean any responsible dependent or babysitter, age thirteen (13) or older. Dependents of a member are entitled to the same privileges as the member and are subject to the same rules and regulations.

SECTION II: POOL ADMISSION Before entering the pool area, every member must check in with the desk attendant in the guard shack. Admission and registration of guests are covered in SECTION V, GUEST POLICY. All member children under thirteen (13) must be accompanied by an adult or guardian during their visits to the pool.

SECTION III: SWIM AND DIVING AREA RULES Pool Usage Rules: As noted above, the Lifeguards are delegated responsibility by the Board for the safety, order, and cleanliness in and around the pool and adjacent grounds including daily enforcement of these rules and regulations.

- No one shall use the pool unless a certified lifeguard is on duty.
- Lifeguards should NOT be talked to in casual conversations by members or guests while on the stand.
- Showers should be taken before entering the pool.
- Lifeguards are NOT responsible for the wading pool area.
- Bathing suits or hemmed cut-offs are required to enter the pool.
- Running, pushing, wrestling, or other forms of horseplay are prohibited in and or around the pool.
- Hanging on Pool Basketball net, rim or backboard is not allowed.

- Persons having infections of the skin, eyes, respiratory or gastrointestinal system, or wearing bandages will not be allowed to use the pool.
- Tubes, floats, or rafts will be allowed in the pool at the discretion of the lifeguards.
- ABSOLUTELY NO GLASS CONTAINERS OF ANY KIND WILL BE ALLOWED IN THE POOL AREA.
- Lifeguards have full authority to clear the pool of swimmers at any time.
- A ten (10) minute recess will be enforced every hour. All swimmers under age eighteen (18) MUST leave the pool during this recess.
- Diaper aged children shall wear disposable swim diapers or rubber pants over diapers when in the pool.

Pool Diving Area Rules:

- Use of the diving boards and deep-water area will be at the discretion of the lifeguards.
- Only one person will be allowed on a diving board at a time; others are to wait on the deck.
- No diving or jumping from the side of the board.
- No diving from the side of the pool into the diving area.
- No hanging from the edge of the diving boards. .
- No swimmers are allowed in the diving area while anyone is diving

SECTION IV: FOOD AND EATING For your safety, NO GLASS CONTAINERS WILL BE ALLOWED ON CLUB PROPERTY. All food and drink must be consumed in the designated areas. No food, drinks, or chewing gum will be allowed in the pool. Appropriate containers should be used for all waste. PLEASE DO YOUR PART TO KEEP THE POOL AREA CLEAN AND SAFE.

SECTION V: GUEST POLICY All Guests must adhere to the WVSRC policies, procedures, and posted rules at all times while visiting the Club. Members are responsible for the conduct of their Guests at all times. Below is specific information regarding Guest admittance and usage of the Pool Areas. Admittance and usage of the WVSRC facility of ANY Non-Member/Guest is only allowed when accompanied by a Member of at least thirteen (13) years of age, and whose family is in good standing with WVSRC.

- Daily Guest pass fees for any non-member to use the WVSRC pool facilities are \$5.00 per day per guest (2 years of age or older). Bulk passes are available at the following rates: Pack of 5 for \$20, Pack of 10 for \$37.50, Pack of 20 for \$65.
- Members bringing greater than ten (10) guests at one time may be required to register and pay a rental fee for guests.
- Prospective Members are allowed to access the Pool for a trial period of no more than 3 days. Prospects will not be allowed to access the pool during holidays and/or holiday weekends.
- Member's nannies/babysitters are allowed to use facilities, without charge, as long as with Member's children and has been previously added to the Member's account as a childcare provider-only 2 childcare providers are permitted per membership. They are not allowed to use the facilities when not caring for a Member's children.

SECTION VI: GENERAL TENNIS COURT RULES AND RESERVATION POLICIES General Tennis Court Rules The tennis courts have a locked gate. It is the member's responsibility to see that the gate is locked after entering and leaving the courts. One court key may be requested per membership. A key deposit is required for annual members. A first-come, first-serve policy will be in effect with the following exceptions:

- Club sponsored tournaments, clinics, etc.,
- Advanced Court Reservations for league play.
- Court Reservation Rules and Policies
 - 4 Courts are to be used for tennis and pickleball only.
 - Reservations are limited to adult members only.
 - All guests must be accompanied by a member.
 - To protect the tennis court surface, players must wear shoes with smooth, non-marking soles.
 - No profanity, unsportsmanlike conduct, or excessive noise will be allowed on the courts.
 - All courts may be reserved for up to two hours prior.
 - After a 10-minute grace period, reserved courts become available to any waiting or walk-on players.
 - Walk-on play is permitted on courts that have not been reserved and is limited to one and one-half hours if there are waiting players.
 - Courts are to be surrendered immediately upon expiration of time for next reservation, or if players are waiting.
 - Courts are restricted to one court per family if there are waiting players.
